To be eligible for the option to pay membership fees monthly by Direct Debit - this Authority MUST be returned to the office on or before 19 February 2019.

In signing this authority you will be agreeing to pay the annual subscription IN FULL irrespective of any change in your circumstances during the Club's financial year. This authority will remain active until advice is received to not continue your membership for the next financial year (which must be received on or before the 1st of March of the applicable year). If there are insufficient funds in your nominated bank account on the day that the payment is drawn from your account, a default fee of \$15.00 will be charged. (Fees are subject to change each financial year.)

Terms and Conditions

I ("the member") hereby acknowledge and agree that I am liable for payment of the total annual membership subscription and dishonour fees for the applicable financial year.

I agree that I am required to pay the annual subscription IN FULL irrespective of any change in my circumstances during the Club's financial year.

I agree that the first monthly payment will include the monthly membership subscription plus Affiliation fees and Insurance (in full) for the applicable year, as well as any other identified additional fees (such as buggy shed rental, buggy insurance, cart access fee and lockers) and will be deducted from my nominated bank account on the 7th March of each financial year.

I acknowledge that I have given authority to the Club to directly debit from my nominated account the first monthly payment (as above) on the 7th March of each financial year and then eleven equal Membership subscription payments on the 7th day of each month thereafter. In the event of a jointly held account, I warrant that all necessary account holders have also provided the required authority.

I agree that this Deduction Authority will roll over with the same terms and conditions for each new financial year and payments will start on the 7th of March of each new financial year. If I do NOT wish to continue my membership into the next financial year, I agree to advise the office of my resignation before the 1st March of that financial year. If I intend to change my status to a different category of membership, I agree to notify the office prior to the 1st of March of that financial year.

I agree that should my financial institution dishonour a drawing or direct debit, that I shall be charged a **dishonour fee of \$15.00 and I will be liable to the Club for all associated fees. I further agree that should my monthly instalment default more than once I will be deemed to be unfinancial and will lose my rights and privileges of membership until this payment is received.**

In the event that the Club is required to take any enforcement action to recover the annual subscription I agree to be responsible for the Club's reasonable enforcement costs including legal costs in recovering the annual subscription or part thereof.
